

Campus Entrance / Gate Access Update

On Monday, May 24, WVC will be implementing several changes at our campus entrances.

- 1. Current screening stations will be relocated to the Manor Main Entrance (off Locust Lane) on the Manor Campus and the Lakes Main Entrance (off Beaver Valley Pike) on the Lakes Campus.
- 2. Vaccinated Residents will no longer be required to be screened. All others entering both campuses will need to continue to be screened.
- 3. A number of campus entrance roads will be re-opened along with a number of new, automated gates.

The following provides additional information about what to expect at each road/gate starting Monday, May 24.

Manor Campus

Manor Main Entrance

- Road barricades will be removed; the gate house will be staffed 24/7, and the automated gates at this location will be operational.
- This location becomes the new screening entrance for the Manor Campus.
- Anyone coming through either one of the two entrance lanes will be screened before proceeding onto campus.
- Anyone may exit the campus through the exit gate at this location.

Providence Park Entrance (at The Clubhouse)

- Road barricades will be removed; the unmanned automated gates at this location will be operational.
- Only Vaccinated Residents will be able to enter the campus through this gate via their activated vehicle ID tag. No screening required.
- All others must enter the Manor Campus through the Manor Main Entrance and be screened.
- Anyone may exit the campus through the exit gate at this location.

Guest Suites Entrance (formerly Arbor View)

- Starting May 24, this road will be barricaded and closed in preparation for the installation of a gate house and gates at this location.
 - ♦ Construction is anticipated to be completed in 6-8 weeks.
- The screening station currently located at the Manor Club will be relocated to the Manor Main Entrance effective May 24.

Lakes Campus

Lakes Main Entrance (off Beaver Valley Pike)

- Road barricades will be removed; the gate house will be staffed 24/7, and the gates at this location will be
 operational.
- This location becomes the new screening entrance for the Lakes Campus.
- Anyone coming through either one of the two entrance lanes will be screened before proceeding onto campus.
- Anyone may exit the campus through the exit gate at this location.

Lakeside Entrance

- Road barricades will be removed; the unmanned automated gates at this location will be operational.
- Only Vaccinated Residents will be able to enter the campus through this gate via their newly activated vehicle ID tag. No screening required.
- All others must enter the Lakes Campus through the Lakes Main Entrance and be screened before proceeding to the Lakeside gate. Once at the entrance gate, the gate will be remotely activated.
- Anyone may exit the campus through the exit gate at this location.

Welcome Center/Property Management Entrance

- Road barricades will be removed; the unmanned automated gates at this location will be operational.
- Only Vaccinated Residents will be able to enter the campus through this gate via their newly activated vehicle ID tag. No screening required.
- All others must enter the Lakes Campus through the Lakes Main Entrance and be screened.
- Anyone may exit the campus through the exit gate at this location.

Gables Entrance (from Peach Bottom Road)

- Road barricades will be removed; the unmanned automated gates at this location will be operational.
- Only Vaccinated Residents will be able to enter the campus through this gate via their newly activated vehicle ID tag. No screening required.
- All others must enter the Lakes Campus through the Lakes Main Entrance and be screened.
- Anyone may exit the campus through the exit gate at this location.

Cultural Center Drive Entrance

- This road will be barricaded and closed in preparation for becoming a temporary SouthPointe construction road entrance on June 1.
- The screening station currently located at the Upper Level Cultural Center will be relocated to the Lakes Main Entrance effective May 24.

SouthPointe Entrance (from Violet Avenue)

- This road will remain open to construction traffic through June 1.
- Beginning June 1, this road will be barricaded and closed in preparation for the installation of a gate house and gates at this location.
 - ♦ Construction is anticipated to be completed in 6-8 weeks.

We realize that the above is a lot to digest. However, we are confident that it will all become commonplace once we all begin to use and become accustomed to the new gates and procedures.

Some other notes:

- Pedestrians are not to use (walk under) any gates; please walk around/continue to use sidewalks.
- All entrance gates have a push button call station located at the gate. If at any time you need help or assistance while at a gate in your vehicle, please push the call button. You will be immediately connected with a Security Officer who will be happy to assist you.
- Bicyclists Sufficient space is provided at the end of each gate to navigate around the gate. Bicyclists who are still required to go through screening must enter a campus via a main entrance and be screened.
- Vehicle ID Tags A future Communique will be forthcoming to explain the new process for Residents to obtain a new vehicle tag, to request a replacement tag, or to report a tag no longer in use.

COVID-19 - Testing Center Changes

Starting on Monday, May 24, 2021, the COVID-19 testing center will be relocated from The Clubhouse to Chautauqua Hall. Days of operation are Monday and Tuesday. Residents do NOT need to make an appointment but can come between 9:00 AM - 11:00 AM if they need a POC (rapid) COVID-19 test.

Phased Opening of Amenities

Willow Valley Communities is excited to be entering the next phase of our opening plan with restrictions being lifted on many amenities at the Cultural Center, The Clubhouse, and in the Communities. Several factors were taken into consideration as the plan was developed, including, but not limited to, Resident vaccination rate (over 95%), masking requirements (as referenced in the May 18 edition of the Communique), capacity limits, and limitations for visitor access.

Capacity limits in place for the state of Pennsylvania:

- Outdoors: up to 75% capacity until June 1, when we can resume full occupancy in outdoor spaces
- Indoors: up to 50% capacity until June 1, when we can resume full occupancy in many indoor areas

Access to amenities is for RESIDENTS ONLY to maintain protection of herd immunity. Visitor access continues to be restricted to Resident apartments/patios, outdoor walking paths, and limited outdoor reservable spaces (i.e., Chautauqua Hall Patio and The VUE).

Please note that amenities are available to all Residents regardless of vaccination status. Unvaccinated Residents are welcome to participate in all amenities as long as they comply with masking requirements.

<u>Cultural Center – Center for Vitality</u>

- Locker Rooms open for use on May 24
- Effective June 1 we will be eliminating the Amenity Pass requirement for the Aquatics Center. Residents may utilize the Aquatics Center at their convenience during regular hours of operation, Monday Friday,
 6:00 AM 6:00 PM and Saturday from 8:00 AM 2:00 PM
- Amenity Passes remain in place for the Fitness Center

<u>Cultural Center – Upper Level</u>
